The Lucca Comics & Games 2006 Convention is organised by the company Lucca Comics & Games S.r.l., whose head office is in Via della Cavallerizza 11, 55100 Lucca.

Exhibitors intending to take part in the Convention must send their application form to the Organisation Office at "Segreteria Organizzativa, Lucca Comics & Games 2006", Via della Cavallerizza 11, 55100 Lucca, tel. +39 0583/48522 fax +39 0583/91203, or by email sent by and not later than 30/6/06 to info@luccacomicsandnames.com info@luccacomicsandgames.com.

2. A deposit equal to 30% of the total cost of the booth must be lodged by and not later than 30/6/06 by bank transfer made out to "Lucca Comics & Games S.r.l.", c/o Cassa di Risparmio di Lucca - Piazza S. Giusto 10, Lucca – ABI 06200 – CAB 13701 C/c 000004034864 cod. cin. "Z", or to postal current account made out to "Lucca Comics & Games S.r.l." c/o Poste Centrali – via Vallisneri, naming the reason for the deposit as "Anticipo Stand" [Booth Deposit]. Beceint of navment must then be sent with the annication form to Receipt of payment must then be sent with the application form to the Organisation Office at Segreteria Organizzativa, Lucca Comics & Games. Boothes will be allocated on the basis of first come, first served and according to the final decision of the Organisation. Allocation of exhibition space will be communicated to the Exhibitor by letter, fax or email. The Organisation will consider the application forms received by 30/6/06 and allocate boothes that are still available until all the boothes have been allocated.

Final payment must be made by and not later than 15/9/06. Failure to make final payment by said date will result in being excluded from taking part in the Convention. The company Lucca Comics & Games S.r.I. will not return the sum paid as deposit. Payments will absolutely not be accepted during the Convention.

4. The Convention will start on 1/11/06 and will remain open from 10.00 a.m.-7.00 p.m. On 2, 3, 4 and 5 November 2006 the Exhibition-Market will be open from 9.00 a.m. to 7.00 p.m.

5. Absence on the opening day will constitute the Exhibitor's tacit decision not to take part in the Convention and will result in the company Lucca Comics and Games S.r.l. retaining the total amount paid, including as payment of damages.

Exhibitors will be able to access the Convention center in order to put up their boothes from 9.00 a.m. to 10.00 p.m. on the day prior to the opening of the Convention (i.e., on 31/10/06). Only Exhibitors accredited within said hours will be able to set up their boothes until 1.00 p.m. Setting-up may also be done between 7.30 a.m. and 9.00 a.m. on the opening day (1/11/06). On the remaining days, exhibitors may access their boothes an hour before the Convention is opened to the public (i.e., at 8.00 a.m.). Stalls may be dismantled only from 7.00 p.m. to 11.00 p.m. on the last day of the Convention and from 8.00 a.m. to 1.00 p.m. on the day following (i.e., 6/11/06). Such operations will on no account be permitted outside the given times and could lead to exclusion from taking part in future Conventions.

Exhibitors who require to leave their equipment and/or material with a courier or a carrier outside the given times must communicate this beforehand to the Organisation and leave the packed equipment and/or materials in a place agreed with the Organisation, for no longer, however, than two days after the Convention closes. A porterage service for transferring such equipment and/or material may be requested (see Optionals form). No kind of private vehicle is allowed in the exhibition area during the Convention. The Organisation asks Exhibitors to use full care and diligence when setting up boothes. It is, in any case, forbidden to allow materials to exceed the dimensions of the booth or to allow them to obstruct passageways and common areas. In such cases, the Organisation reserves the right to arrange for compulsory removal of materials that exceed said dimensions. Compensation for any damage caused by the Exhibitor to the booth allocated to him must be fully paid to the company Lucca Comics & Games S.r.I., which, however, reserves the right to take legal action. The Organisation requires that goods, materials, mountings and gear brought to the Convention by the Exhibitor be covered by an "allrisks" insurance policy that waives any compensation from third parties, including from the company Lucca Comics & Games S.r.l. The Exhibitor expressly exempts the company Lucca Comics & Games S.r.l. from liability for damage, however caused, that may occur to the goods, materials, mountings, and gear brought to the Convention and gives prior waiver of any kind of action for responsibility on said company's part. All Exhibitors are given Civil Personal Liability coverage for physical injury or damage caused to third parties. For the purposes of this guarantee, Exhibitors are regarded as third parties one to the other (with the exception of damage to things).

The list of names to be included on badge must reach the Organisation Office by 8 and not later than 22/9/06. Thereafter, said badge can be picked up at the Accreditation Point, along with parking permits.

All delivery and transport costs will be borne by the Exhibitor. The Organisation is relieved by the Exhibitor of liability for injury or damage to persons and things resulting from any event such as theft, loss, deterioration, fire, acts of vandalism, socio-political events, weather conditions, etc., that may take place during transport to and from the Convention or during the time that the Convention takes place. A surveillance system will be in operation throughout the whole duration of the Convention.

10. It is forbidden to exhibit goods in the allocated space that are at variance with the types of goods specified on the Registration Form or goods that are not useful to or may damage the image of the Convention. Failure to comply with these prohibitions may result, in the final decision of the Organisation and in relation to the gravity of the failure, any or all of the following: compulsory removal of the material exhibited, immediate closure of the booth or area, withdrawal of pass, and ban on the Exhibitor from entering the places in which the Convention is taking place. The company Lucca Comics & Games S.r.l. also reserves the right to apply to the competent judicial authorities.

11. The Organisation's decisions are final and cannot be appealed against. The Organisation, in its unchallengeable judgement, reserves the right to alter the dates on which the Convention will take place, vary opening and closing times and change the internal distribution of single structures. Such variations will not give the Exhibitor any right to reimbursement.

12. In the case of *force majeure* the Convention may be cancelled without any responsibility falling on the Organisation.

13. The Registration Form is personal and the booth allocated cannot be given to or shared with others. Should it be, the allocation may be cancelled.

14. In the case of any dispute, these Conditions of Participation, in Italian, are binding.

15. Taking part in our Convention depends on acceptance of all these Conditions of Participation which form an integral part with the Registration Form. Participation does not imply any duty of hospitality on the part of the Organisation.

16. The Exhibitor elects domicile in the head office of Lucca Comics & Games (Via della Cavallerizza 11, 55100 Lucca). In the case of any dispute, the Court of Lucca has exclusive competence.

17. For anything not foreseen by these Conditions of Participation, please refer to the dispositions in the Civil Code.

In applying to participate in Lucca Comics & Games 2006 I declare that I have read and accept these Conditions of Participation and undertake to observe them and to ensure observance of them in all parts by others working with me at the Convention.




